



Event Terms and Conditions

MovNat® Trainer Certification Workshops

Please read these MovNat Terms and Conditions, they form the basis of the Contract between you and MovNat, LLC.

Your contract is with MovNat, LLC, a US based company specializing in Functional training and Evolutionary Lifestyle. Outdoor training carries inherent risks, and if you are concerned about participating in our outdoor training, please contact us prior to booking.

1. Your MovNat Certification Workshop

A MovNat training area, designed by MovNat® founder Erwan Le Corre, will be the basis for your certification training. You will be under MovNat supervision at all times during your training, and training will be adapted to any limitation and/or injury you may have. Training is structured, scalable and carries the normal risks involved with being in a natural environment. The workshops can be conducted outdoors or indoors, depending on the local logistics and you are responsible for wearing the appropriate protection based on the weather and environment of the area.

2. Reservations, Deposits and Other Methods of Payment

This contract is in effect when initial payment is received. If upon reviewing your online Health Questionnaire, MovNat believes that your attendance at the Workshop may put you at risk, MovNat will contact you to discuss your options, and a full refund may be given. When you make a booking you guarantee that you have the authority to accept and do accept on behalf of your party the terms of these booking conditions. We also do not accept deposits, checks, cash, delayed payments, barter or grant discounts. Payments must be made in full exclusively through EventBee/Paypal.

3. Refund Policy

Any cancellation or early departure by you during your course, or any limited use of our facilities or activities included in the cost of the course will not entitle you to a refund.

Refunds for weather conditions will not be given.

Participants will be able to change to a different course, at no extra cost, up to 4 weeks before their original intended course if spots are available. With prior agreement with MovNat, a participant can also change the name of their ticket.

4. Modifications by MovNat

It is unlikely that we will have to make changes to your workshop, but we do plan the arrangements many weeks in advance. Occasionally, we may have to make changes and we reserve the right to do so at any time. We may modify the list of activities (e.g. sports) and facilities (e.g. equipment and services) included in the workshop, together with the dates of opening and closure of the centers (depending on the occupancy of the relevant center).

5. Cancellation by MovNat

We reserve the right to cancel your course in any circumstance. For example, if the minimum number of participants required for a particular workshop is not reached, we may have to cancel it. In this event we will inform you as soon as practical and you will have the choice of having a Full refund of all monies paid or accepting an offer of an alternative course of comparable standard from us, if available (we will refund any price difference if the alternative is of a lower value). This would exclude independent travel arrangements.

6. Price Changes

The prices for MovNat Certification workshops as shown are subject to change, especially closer to the event date. If you have already paid for your reservation, your price will not change.

7. Liability

MovNat does not accept liability or pay you compensation where the performance of our contractual obligations is prevented or affected by 'force majeure'. This means that we will not pay you compensation if we have to cancel or change your workshop in any way because of unusual or unforeseeable circumstances beyond our control.

In these booking conditions 'force majeure' will include (but shall not be limited to) war, threat of war, riot, civil or political unrest, industrial dispute, terrorist activity threatened or actual in its consequences, natural or nuclear disasters, fire, adverse weather conditions, closure of ports or airports, air traffic control delays, technical problems of transport or other circumstances amounting to force majeure.

8. Travel Requirements

You are responsible for knowing what is required for you to travel into the country prior to your departure. MovNat will not offer refunds due to your inability to enter the country. Non-local persons must check with the Consulate or Embassy for entry requirements.

9. Valuables

MovNat strongly recommends that you leave valuables at home and takes no responsibility in case of loss or theft.

10. Complaints and Arbitration

MovNat takes your satisfaction very seriously and strives to give you an excellent experience. If you have a problem during your workshop, you are obliged to inform our local staff immediately who will endeavor to correct the issue immediately. If your complaint is not resolved during your workshop, please follow this up in writing within 28 days of completion of your workshop.

You must communicate any complaint to our staff without delay and complete a report of your complaint while on site. If you fail to follow this simple procedure we will have been deprived of the opportunity to investigate and rectify your complaint while you were with us and this may affect your rights under this contract.

11. Responsibility Waiver

- a) We accept responsibility for ensuring that the workshop which you book with us, is supplied as is described on our website. If any part of your course is not supplied as promised due to the fault of our employees, agents or suppliers, we will pay you appropriate compensation if this has affected the enjoyment of your course.

- b) If you or any of your party suffer death, illness or injury of an activity which does not form part of your workshop, we shall offer assistance and cooperation to the authorities and the party's immediate family, however this does extend to financial compensation to us.

- c) The contract is made on the terms of these booking conditions, which are governed by New Mexico State and US Federal laws, and the jurisdiction of the New Mexico courts.

- d) By booking and attending the workshop you accept the inherent risks of physical training in an outdoor environment and will not hold MovNat accountable for any injuries due to these inherent risks. MovNat takes every precaution to train you safely within this natural environment and within your physical limitations.
